EXHIBIT RULES AND REGULATIONS

- The festival will begin at the times specified above each day. Exhibitors may begin setting up at 9 AM each day.
 Parking will not be permitted in festival area from one half hour before gates open until fifteen minutes after show closes each day. All loading and unloading must be planed around these hours and vehicles must be removed to exhibitor parking area before the shoe opens each day at 12PM.
- One 12' x 12' space will cost \$50 to set-up for both days. (No single day vendors.) Exhibitors are responsible for bringing their own tables, chairs, and canopies. The festival will be held rain or shine, so please come prepared.
- Limited electrical outlets are available for \$9 each. If requesting electrical outlet, you are responsible for bringing extension cords (heavy-duty 3 prong type.)
- No Pets are permitted on grounds.
- Vendors will consist of arts/crafts and independent business consultants will consist of Mia Bella, Tupperware, etc.
- The Wine Festival committee reserves the right to disallow some items and limit some categories. Vendors can only
 sell items that were detailed in their application. New vendors must provide pictures, illustrations, or brochure of your
 work with your application. The pictures will not be returned unless you enclose a self-addressed stamped envelope.
 Crafters can sell no food products unless approved by the committee.
- Exhibitors are requested to remain set-up for the entire event. Exhibitors must clean-up their area before departing.
- Upon receipt of your contract, a space will be reserved in your name. Spaces will be on a first come, first served basis. Spaces are limited. Your registration will be verified by e-mail.
- Each vendor must have a PA State Tax ID number. The number must be provided on the application.
- Vendors may purchase tickets for wine sampling at the pre-sale cost upon arrival Saturday morning.
- Booth assignments are subject to the sole discretion of the festival committee. Every effort will be made to honor any
 requests made.
- The Pleasant Hill Vol. Fire Co. and West Manheim Township Lions Club are not responsible for any lost or accidents during the entire event.
- Please make all checks payable to Wine Tasting on the Hill. Please note that all registration fees are non-refundable.
